

## Disclosure Log - Government Information (Public Access) Act 2009

Under section 25 of the GIPA Act, a Council must keep a record (called its "disclosure log") that registers information about access applications made to and decided by Council to provide access (to some or all of the information applied for) if Council considers the information may be of interest to other members of the public.
