## PART 7. INFORMATION TO BE SUBMITTED WITH APPLICATION

- An A3 or A4 sized plan drawn to scale showing the location of the proposed works in relation to any buildings and property boundaries
- Arborist reports may be required for applications:
  - a. For significant trees
  - b. If the justification given for the clearing of the vegetation is not supported by the evidence
- A landscape plan illustrating replacement native species plantings will be required for applications for remnant native vegetation
- Any photos of current state of trees to be removed
